***In Quest of Foundations of Peace and Co-existence of Muslims in the world community***

The present work is a review article on the book of *An Islamic approach to the international law*, written by Dr. Mohaqqeq Daamaad. In it, the following traits are observable: a comprehensive view to making references to all Islamic schools, a comparative approach, an ethical orientation towards inferring Islamic legal rules, and giving priority to the Holy Quran as a source of Islamic rules and verdicts, the rules of jihad, making a separation between Islamic ideals, and the profile of some rulers in the guise of jihad. These make the main approaches that can contribute to the field of international law. All discussions are followed by some further questions for more explorations, all on the basis of a humane and compassionate view to portray permanent peaceful relations amongst Muslims worldwide.
